Item	Activity	Timescale
Accessible car parking	Accessible car parking is in place – one disabled parking space is available in the car park.	Completed
Access to Reception – main school entrance	Wheelchair users are able to access the main reception by entering the school via the KS1 playground (there is a lowered telecom system for wheelchair users) and entering the school by the door opposite. There is a wheelchair lift to enable access to the main office.	Completed
Internal Wheelchair access	Wheelchair users are able to navigate through all internal doors.	Completed
Corridor Width 1.2m	All corridors are at least 1.2m in width but some would require items being moved out of the way when necessary for wheelchair users	Completed
Signage – non-visual	There is no non-visual signage in place across the school as there has not been a need for this to be put in place. Provision will be put in place if and when required	As and when required
